

Mrs M's Education Fund 2025/26

Introduction

The Mrs M's Education Fund is a maintenance bursary awarded to outstanding female students in their final year of study from the Law, Digital Media and Communication, and Accounting and Business Management programs. Established in loving memory of Mrs M, this bursary honours her legacy of empowering women and breaking down barriers like the "glass door." By providing financial support, it aims to enable talented students to focus on their studies. The hope is that one day, recipients will give back to their communities, continuing the cycle of support.

Three eligible students will receive a one-time grant of £2,000 during their final year, with payment being made before the end of the year.
