This book analyses the four treaties establishing nuclear weapon-free zones in densely populated areas, the 1967 Tlatelolco Treaty, the 1985 Rarotonga Treaty, the 1995 Bangkok Treaty and the 1996 Pelindaba Treaty. After discussing the history of the concept and its application in the framework of disarmament/non-proliferation, the book examines the denuclearization obligations of the states parties to the four treaties.

Chapter II discusses whether the nuclear weapon-free zone treaties establish a 'territorial objective regime', an erga omnes territorial status which must be respected by all states, not only by the contracting parties. Even accepting this doctrine (which is highly controversial), the book concludes that the treaties on nuclear weapon-free zones fall short of the necessary requirements to establish an objective regime.

Chapter III analyses the territorial scope of application of the four treaties. It is not clear whether the four treaties allow the passage through the zones of ships and aircraft carrying nuclear weapons. Chapter IV tries to answer this question by distinguishing between the marine spaces and the airspace of the contracting parties, and between the waters over which states exercise full sovereignty and those over which they only enjoy sovereign rights.

Chapter VI examines the negative security assurances provided by the nuclear weapon states to the denuclearized states, which are contained in the protocols additional to the main treaties. The chapter also analyses the problem of the legality of the declarations issued when signing the additional protocols, through which the nuclear powers have set limitations to the negative security assurances.

Chapter VII analyses the mechanisms for verifying compliance. Apart from the specific measures provided in each treaty, the remedies provided by customary international law (i.e., countermeasures) and other treaty law (e.g., intervention by the organs of the UN or of regional organizations) are discussed in depth.
