25.20	STAYING SAFE: BUSINESS CONTINUITY GROUP UPDATE		
25.20.1	The University Secretary and Chief Operating Officer (USCOO)/Co-Chair, Staying Safe: Business Continuity Group informed members that a business continuity workshop had taken place recently and went well.

25.24	POSTGRADUATE RESEARCH EXPERIENCE SURVEY (PRES) OUTCOMES		
25.24.1	Dr Margherita Sprio - Head of the Graduate School - presented the PRES outcomes report (Document UEB 251007D).		
25.24.2	The DVC (RKE) informed members that the overall satisfaction rate for postgraduate research students was 82% and the University's response rate was high compared to the rest of the sector. Members heard that postgraduate research students' experience is a major focus for the coming year.		
25.24.3	The Head of the Graduate School confirmed that such high performance in student satisfaction is unusual in the sector, and this success is due to the Virtual Research Environment (VRE). She also reported that the University does well on quality of supervision and assessment, yearly checking and progressions.		
25.24.4	Members heard that areas for improvement are understanding of research culture, resourcing and technical resourcing.		
25.24.5	The Head of the Graduate School explained that there will be a mid-year review on action plans in February 2026 and regular meetings with PhD Coordinators. She reported that the Schools are not comparable in terms of research and Coordinators have been asked to communicate and share research seminars and events.		
25.24.6	The Head of the Graduate School reported that the whole sector performs poorly on research culture and acknowledged that there is work to be done on this area. Members noted that Readers and Professors will be encouraged to engage proactively with doctoral researchers.
