22.160 ANNOUNCEMENTS

22.160.1 **Welcome:** The Chair welcomed all members and attendees to the meeting.

22.160.2 **Apologies:** Apologies were received as noted above.

22.160.3 **Requests to discuss starred items:** There were no requests to discuss starred items or items of business not on the agenda.

22.160.4 **Chair's business:** The Chair invited Malcolm Kirkup, Pro Vice-Chancellor (PVC) for People and Culture to update members on current industrial action and the mitigations in place.

22.161 STAYING SAFE: BUSINESS CONTINUITY GROUP UPDATE

22.161.1 Sal Jarvis, Deputy Vice-Chancellor (DVC) for Education and Co-Chair of the Group updated members on the Staying Safe: Business Continuity Group and reported on business continuity plans following the recent disaster recovery exercise, recent evacuations at Regent Street and New Cavendish Street and on student behaviour.

22.162 UWSU BLOCK GRANT REQUEST 2023/24 AND STRATEGIC DEVELOPMENT PLAN

22.162.1 Zahra Butt, UWSU President and Michael Wigg, UWSU Chief Executive Officer (CEO) presented the UWSU block grant request 2023/24 and strategic development plan (Document UEB 230425A).

22.162.2 Ian Wilmot, Director of Finance, reminded members that the Students' Union were asked to refine their block grant request following submission to the UEB meeting on 28 February 2023.

22.162.3 Members heard that the HR department carried out market testing and advised where the proposed additional posts map to the University's salary scale.

22.162.4 The UWSU CEO informed members that job descriptions for the additional roles had been provided as requested by UEB and there was clear commitment to support international students.

22.162.5 In response to a member's query on the figures used for the additional funding requests, the UWSU CEO confirmed that the first table shows the median figures and the second shows the

top quartile difference. The USWSU CEO also confirmed that the third table shows the salaries that would be implemented on approval.

22.162.6 **APPROVED** Members allocated a block grant of [REDACTED] to the Students' Union for the 2023/24 financial year.

22.163 WORKFORCE PLANNING

22.163.1 The Chair agreed to withdraw the item on workforce planning².

22.164 CAPITAL PROJECTS BUSINESS CASES

22.164.1 Chris Hinge, Director of Estates, Planning and Services (EPS) and Alessandra Foderaro, Deputy Director Capital Development (CD), presented the list of capital projects business cases (Document UEB 230425C) and tabled supporting documents (Documents UEB 230425H to K) for consideration.

22.164.2 In response to a members' query on outstanding actions for the College of Liberal Arts and Sciences (LAS), the Director of EPS clarified that the College would have another opportunity to add items to the capital projects pipeline.

22.164.3 Members discussed the lists of capital projects and comments covered:

- The proportion of projects focus on delivering authentic teaching learning and assessment.
- Return on investment.
- How we bring together specialist and general teaching spaces.
- Equipping the Colleges to deliver new courses and teaching efficiencies.
- Articulation of the benefits of the new projects to help with prioritisation.

22.164.4 **AGREED** Members will hold a special meeting to prioritise and consider approval of capital projects. The meeting will allow for an informed judgement considering student numbers, growth and profit.

22.164.5 Members noted that the Heads of Colleges would need further discussions with their finance partners to consider financial return and enhanced retention prior to the meeting.
