

## ACADEMIC COUNCIL

### Terms of reference 2025-26

Academic Council is a sub-committee of the Court of Governors and - [subject to the provisions in paragraph 24 of the Articles of Association](#) - the University's most senior committee in relation to academic matters.

The purpose of Academic Council is to oversee academic strategies, policy, and regulatory matters, and to provide assurance to the Court of Governors that academic governance is robust and effective.

Specifically, Academic Council will:

- 1) Deliberate and decide on general issues relating to research, scholarship, teaching, employability and courses at the University, ensuring alignment of decisions with the University Strategy: Being Westminster 2022-29 and relevant supporting strategies.
- 2) Consider and provide advice to the Vice-Chancellor and the Court on:
  - a. development of the academic activities of the University and the resources needed to support them<sup>1</sup>;
  - b. matters concerning the educational character and mission of the University; and
  - c. matters concerning equality, diversity and inclusion in our educational endeavours.
- 3) Provide assurance to the Court on academic standards and the integrity of academic qualifications – including programmes delivered through academic collaborations and partnerships - and confirm that key academic risks are being effectively managed.
- 4) Provide assurance to the Court that academic governance is robust and effective and complies with the Higher Education Code of Governance<sup>2</sup>.
- 5) Approve University-level academic strategies and policies as designated in the University's strategy and policy matrix. Where appropriate, Academic Council will consider and recommend approval of certain University-level strategies and policies to the Court.
- 6) Monitor the effectiveness of academic strategies and policies and the progress and achievement of agreed academic strategic performance indicators and targets.
- 7) Oversee the University's academic portfolio and, within the scope of the educational character and mission of the University determined by the Court, determine the content of that portfolio.
- 8) Approve the University's academic and student regulations and the awards which the University may validate and confer.
- 9) Validate the University's programmes of study<sup>3</sup>.
- 10) Award students academic credit and confer upon students academic awards of the University<sup>3</sup>.
- 11) Approve the appointment and removal of External Examiners<sup>3</sup>.

## **Quorum**

A quorum of the Academic Council shall comprise a minimum of 40% of the ex-officio, elected and nominated members, including the Chair or a Deputy Chair.

## **Terms of office**

Elected/nominated members shall serve a term of office not exceeding three years commencing 1 August in the year of appointment. Members may serve a maximum of two consecutive terms of office.

Former elected/nominated members cannot rejoin Academic Council as an elected or nominated member until after a period of absence of no less than one year.

## **Meetings**

Academic Council shall meet at least four times a year. Additional meetings may be called by the Chair as deemed necessary to execute the business of the committee.
