How to advertise with us

You can advertise property by using this form. You will need to fill out one form per property and return it to us using the contact details at the bottom of this page. We require a new form every time the property is vacant along with an up to date Gas Safety Certificate. We also require landlords to provide proof of ownership if they are registering the property with us for the first time.

We will only advertise a maximum of six properties per landlord. However, if you are a large professional landlord with a website, please send us the link and we may be able to put a link to your site.

Please note that we do not advertise properties from agencies, only the property owners themselves.

How the list works

We have one centrally managed housing list that covers all of our campuses. All of our full time, fully enrolled students have access to the list, as do our incoming first year students. The list is available on our intranet, and on paper if requested. This ensures that your details are not directly available to the public.

We will keep your property on our lists until we hear that the vacancy has been filled sooner. If your property is no longer vacant then you will need to email landlords@westminster.ac.uk to request stop advertising the property. If you wish to make any changes to the advert once the form has been returned, please email us and we will update the page. No property will be advertised without a gas safety certificate, and we reserve the right to ask to view the property for ourselves.

Contacting Us

We prefer you to communicate by email where possible, and we will deal with your enquiry as quickly as we are able. It is always best to let us know of any property becoming available as early as possible, to prevent a backlog during August and September.
